I. General Provisions

1. Competition is held from 7 to 8 December, 2019 in the sports hall of Radzyński Ośrodek Kultury i Sportu
 - al. Jana Pawła II 20
 - 05-250 Radzymin
 - Mazowieckie, Poland
2. The main organizer of the Tournament is KS "ROKIS" Radzymin:
 - Stowarzyszenie Kultury Fizycznej – Klub Sportowy „ROKIS”

II. Participants and registration

1. Teams of 3 or 4 archers may take part in the Tournament, recurve and compound division separately.
2. Team may include both men and women, regardless of category, nationality and club membership, born in the year 2003 or older.
 - a. Team is permitted to have one younger participant (born after 2003).
3. Team can have any name, chosen arbitrary by members of the team.
 - a. The name cannot be vulgar or offensive.
 - b. If the team does not choose a name, it will be given by the organizer in form of a name of a country, city, or the club from which the athletes are.
4. The maximum number of 48 teams can participate in the Tournament. In case of more applications, national teams will be given priority and then sequence of applications will be taken into account.
5. Participants may register for the tournament beginning November 6, 2019. The application deadline is November 30, 2019. The form is available on the official website.
6. A payment of an entry fee of 100€ (400 PLN) per Team is a precondition of the registration acceptance and participation.
 - a. Registration must be confirmed by payment of entry fee to organizer's bank account within 7 days after submitting the form. If fee is not paid before deadline, registration will be canceled.
7. If a team misses the registration or payment deadline the organizer reserves the right to decide whether the team will be allowed to the competition or not. In this situation the entrance fee rises to 120€ (500 PLN). Dates of submitting registration form and appearance of entry fee on Organizer's account decide.
8. The list of teams will be updated on the official site.
9. At least one hour before the start of shooting (7 December 11.00) Head of the team is obligated to appear in a registration office (to collect starting numbers, etc.)

III. Competition process

1. Shooting contest lasts for 24 hours from 12.00 on December 7 to 12.00 on December 8 and is divided into 24 lots, hereinafter called Hours.
2. In the course of one Hour, one player (designated by the team) shoots 10 ends of three arrows from a distance of 18 m.
 - a. Results obtained within 10 ends (30 arrows) in one Hour, by a sole competitor, will be included in the individual classification.
 - b. Archers can freely change within one Hour between successive ends, after making notification of changes to the judge. The result of the Hour will not be included in the individual classification.
3. Time limit for one end is 90 s.
4. Any equipment failure should be reported to the judge.
 - a. Missing arrows from end during which the accident occurred are shot after the Hour. If the time to complete the Hour is less than 15 minutes, the player can perform shooting after the next hour.
 - b. If an athlete may not proceed to shoot the next end – replacement by another member of the team should be made (subject to the paragraph III.2.b).
5. One player can not shoot more than 100 ends and less than 40 ends during the tournament.
6. Practice session is possible at 11–11:30 am on 7 December and is not allowed on the competition field during the tournament. Archers can use a practice field during the entire Event.
7. In the case of a tie:
 - a. places 1–8, individual classification (equal number of points, tens, nines) – a shot-off is made (one arrow to the center target during the 20 s). In the case of an equal hit value, distance from the target center is decisive.
 - b. places 1–8, team classification (equal number of points, tens, nines) – a shot-off is made (one arrow shot by each of 3 athletes classified to compete in the shot-off; time limit: 60s). In case of an equal hits value, the shortest distance from the target center is decisive.
 - c. other places in both classifications – athletes or teams are placed equal.
8. Technical judge may inspect the equipment at any time during competition.

IV. Classification

1. Participants will be classified in the following events:

Team classification

(720 arrows shot at the 24 Hours)

- Recurve
- Compound
- Barebow

Individual Classification

(30 arrows shot during any of hours)

- Recurve Women OPEN
- Recurve Men OPEN
- Compound Women OPEN
- Compound Men OPEN
- Barebow OPEN

2. There are 4 Tournament Records to beat:

V. Awards

*Organizer reserves the right to change the prizes depending on the number of competing teams.

3. In the case of breaking the Record, the Team or individual is provided a special award.
4. Money prizes are paid in cash after deduction of tax (10% flat-rate tax on prizes).

VI. Final Provisions

1. Athletes automatically agree to the processing of personal data and image for promotional events (in accordance with the Act dated. 08.29.1997 year the Personal Data Protection Acts. Sett. No. 133, item. 883).
2. In the case of any misunderstandings arising from the interpretation of these Regulations, Polish version shall prevail.
3. In matters covered by these rules shall be decided by Chairperson of the Judge Commission.
4. The Organizer reserves the right to change these policies.
5. Players' insurance must be organized in their own field by the home clubs.
6. Organizer is not responsible for things lost during tournament.
